20 Association of School Business Officials

24 Amend Bill, page 9, line 6, by striking out "AN INSTITUTION"

27 Amend Bill, page 9, line 7, by striking out "AND" where it
28 occurs the first time and inserting a comma

29 Amend Bill, page 9, line 7, by striking out the period after
30 "GOVERNOR" and inserting

31 , and who shall be chosen as follows:

32 (A) One member from a list of candidates submitted by the
33 Chancellor of the Pennsylvania State System of Higher Education.

34 (B) One member from a list of candidates submitted by the
35 Association of Independent Colleges and Universities of
36 Pennsylvania.

1 The organizations required to submit lists of candidates under
2 this section shall provide the Governor with their respective
3 lists of candidates within ten days of the effective date of
4 this section.

5 Amend Bill, page 9, lines 10 and 11, by striking out "BY THE
6 ORIGINAL APPOINTING AUTHORITY." and inserting
7 for the unexpired term by a successor appointed in the
8 same manner as the successor's predecessor.
