

## AMENDMENTS TO HOUSE BILL NO. 1831

1 Amend Bill, page 1, line 3, by striking out the period after  
2 "Bridge" and inserting  
3 ; designating the interchange between the portion of State Route  
4 3009 and State Route 119 in South Union Township, Fayette  
5 County, as the Fred L. Lebder Interchange; and designating a  
6 bridge on that portion of State Route 711 over the  
7 Youghiogheny River in the City of Connellsville, Fayette  
8 County, as the Officer Robb McCray Memorial Bridge.

9 Amend Bill, page 2, by inserting between lines 23 and 24

10 Section 2. Fred L. Lebder Interchange.

11 (a) Findings.--The General Assembly finds as follows:

12 (1) Fred L. Lebder was born on August 1, 1920, in  
13 Collier, Fayette County, as the ninth of ten children.

14 (2) Mr. Lebder was an athlete at Georges Township High  
15 School who graduated from the California State Teachers  
16 College and taught at Point Marion and Georges High Schools.  
17 He served in the Air Force for 41 months during World War II.

18 (3) Mr. Lebder married the former Norma Jean Cole in  
19 1943.

20 (4) Mr. Lebder has been actively involved in public  
21 affairs in Fayette County for 34 years. He served as a  
22 Fayette County commissioner for 28 years and as chairman of  
23 the Fayette County Board of Commissioners for 20 years.

24 (5) Mr. Lebder has earned the respect and admiration of  
25 the citizens of Fayette County through both his commitment to  
26 numerous volunteer organizations and dedicated public service  
27 career.

28 (b) Designation.--The intersection between the portion of  
29 State Route 3009 and State Route 119 in South Union Township,  
30 Fayette County, is hereby designated the Fred L. Lebder  
31 Interchange.

32 (c) Signs.--The Department of Transportation shall erect and  
33 maintain appropriate signs displaying the name of the  
34 interchange to traffic in both directions on the interchange.

35 Section 3. Officer Robb McCray Memorial Bridge.

36 (a) Findings.--The General Assembly finds as follows:

37 (1) Officer Robb McCray served honorably as a member of

1 the City of Connellsville Police Department, and was a  
2 veteran of the Civil War and served with the 110th  
3 Pennsylvania Volunteer Infantry Regiment.

4 (2) While bravely performing his duties, Officer McCray  
5 was killed on May 25, 1892, when he was shot while assisting  
6 another officer arrest two brothers at a circus that was  
7 visiting Connellsville.

8 (b) Designation.--The bridge located on State Route 711,  
9 known as Crawford Avenue, in the City of Connellsville, Fayette  
10 County, over the Youghiogheny River is hereby designated the  
11 Officer Robb McCray Memorial Bridge.

12 (c) Signs.--The Department of Transportation shall erect and  
13 maintain appropriate signs displaying the name of the bridge to  
14 traffic in both directions on the bridge.
