1 Amend Bill, page 1, line 7, by inserting after "for"

3 Amend Bill, page 1, lines 14 through 17, by striking out all

5 Section 1. Section 302 of the act of August 26, 1971  
6 (P.L.351, No.91), known as the State Lottery Law, added November  
7 21, 1996 (P.L.741, No.134), is amended to read:  
8 Section 302. Definitions.

9 The following words and phrases when used in this chapter  
10 shall have the meanings given to them in this section unless the  
11 context clearly indicates otherwise:

12 "Director." The Director of the Division of the State  
13 Lottery.

14 "Division." The Division of the State Lottery created by  
15 this chapter.

16 "Internet instant game." A lottery game in which, by the use  
17 of a computer, tablet computer or other mobile device, a player  
18 removes the covering from randomly generated numbers or letters  
19 which reveal whether the instant ticket is a winning ticket for  
20 which money is paid. A player shall not include a retailer.

21 "Keno." A lottery game commonly known as keno.

22 "Lottery" or "State Lottery." The lottery established and  
23 operated under this chapter.

24 "Secretary." The Secretary of Revenue of the Commonwealth.

25 Section 2. Section 303(a)(1), (8) and (11)(iv) of the act,  
26 amended November 21, 1996 (P.L.741, No.134) and June 30, 2011  
27 (P.L.110, No.23), are amended and the section is amended by  
28 adding a subsection to read:

29 Amend Bill, page 2, by inserting between lines 5 and 6

30 (1) The type of lottery to be conducted, except that the  
31 secretary may not authorize the game of keno or an Internet  
32 instant game unless specifically authorized by law.

34 (8) The method to be used in selling tickets or  
35 shares[.], except that sales through the lottery's Internet

1 website or Internet websites operated by licensed lottery  
2 retailers of any lottery game or any Internet instant game  
3 shall be prohibited unless specifically authorized by law.

4 Amend Bill, page 2, by inserting between lines 21 and 22

5 (a.1) Prohibitions.--The secretary may not offer any  
6 Internet-based or monitor-based interactive lottery game or  
7 simulated casino style lottery game, including video poker,  
8 video roulette, slot machines or video blackjack, through the  
9 State Lottery.
