

## AMENDMENTS TO SENATE BILL NO. 700

1 Amend Bill, page 3, lines 7 through 12, by striking out all  
2 of said lines and inserting

3 (3) Four members appointed by the county executive of the  
4 county where the authority is located composed of the following:

5 (i) Two appointees of the county executive of the county  
6 where the authority is located.

7 (ii) Two appointees who are recommended by the organizations  
8 in subsection (g) by the county executive of the county where  
9 the authority is located subject to confirmation by a majority  
10 vote of the members of the county council.

11 (4) Two appointees who are recommended by the organizations  
12 in subsection (g) by the caucus of county council members in the  
13 county where the authority is located who are not of the same  
14 political party affiliation as the county executive.

22 (1) The appointees under subsection (c)(3)(i) shall serve an  
23 initial term of two or three years as designated by the county  
24 executive.

25 (2) The appointees under subsection (c)(3)(ii) shall serve  
26 an initial term of two years.

27 (3) The appointees under subsection (c)(4) shall serve an  
28 initial term of one year.

29 (g) The appointments made by the county executive under  
30 subsection (c)(3)(ii) and the appointments made by the caucus of  
31 county council members under subsection (c)(4) shall be made in  
32 accordance with the following:

33 (1) The county executive and the caucus of county council  
34 members shall select from a list of recommendations submitted by

1 each of the following organizations to the appropriate  
2 appointing authority:  
3 (i) The Allegheny Conference.  
4 (ii) The Southwest Planning Commission.  
5 (iii) The Allegheny Council of Governments.  
6 (iv) The Committee for Accessible Transportation.  
7 (2) The caucus of county council members shall be granted  
8 the first and fourth selections under this subsection.  
9 (3) The county executive shall be granted the second and  
10 third selections under this subsection.  
11 (4) The county executive and the caucus of county council  
12 members shall coordinate their appointments to ensure that all  
13 of the organizations listed under paragraph (1) are represented  
14 simultaneously on the board.  
15 (h) Except for an appointee under subsection (c)(1) who  
16 shall be a resident of this Commonwealth, appointees shall be  
17 residents of the county where the authority is located
