8 (a) Establishment.--The Additional School District Millage
9 Rate Reduction Fund is established as a special fund in the
10 State Treasury. The fund shall not lapse.

11 (b) Purpose.--Money in the fund shall be distributed to
12 school districts under section 1632 and shall be used
13 exclusively for the purposes enumerated in this article.

14 (c) Deposits into the fund.--Seventy percent of the funds
15 generated by the tax under section 1611 shall be deposited into
16 the fund.

25 Additional School District Millage Rate Reduction Fund shall be
26 equal to one-seventh of the sum of the amount collected under
27 this section and Article II of the Tax Reform Code multiplied by
28 0.70.

19 (b) Notification of Department of Education.--By May 10,
20 2016, and May 10 of each year thereafter, the Department of
21 Revenue shall notify the Department of Education of the amount
22 of funds in the School District Millage Rate Reduction Fund
23 attributable to each school district.

33 Fund and the amount of funds determined under section 1622(a.1).
