7 Amend Bill, page 2, by inserting between lines 2 and 3
8 "Diverse and disadvantaged businesses." A woman-owned
9 business, a minority-owned business or a veteran-owned business.

10 Amend Bill, page 2, lines 11 through 15, by striking out all
11 of said lines

12 Amend Bill, page 3, lines 1 and 2, by striking out "SHALL
13 HAVE THE MEANING GIVEN TO" in line 1 and all of line 2 and

15 A for-profit business that is at least 51% owned and
16 controlled by one or more veterans. The term includes a
17 corporation in which at least 51% of the stock is owned by one
18 or more veterans.
