7 commissions or other compensation by means of a payroll card  
8 account a condition of employment or a condition for the  
9 receipt of any benefit or other form of remuneration for any  
10 employee.

11 (4) Prior to obtaining an employee's authorization, the  
12 employer shall provide the employee with notice, in writing  
13 or electronically, of all of the following:

14 (i) All of the employee's wage payment options.

15 (ii) The terms and conditions of the payroll card  
16 account option, including the fees that may be deducted  
17 from the employee's payroll card account by the card  
18 issuer.

19 (iii) A notice that third parties may assess fees in  
20 addition to the fees assessed by the card issuer.

21 (iv) The methods available to the employee for  
22 accessing wages without fees.

31 (6) The payroll card account shall provide the employee  
32 with a means of ascertaining the balance in the employee's  
33 payroll card account through an automated telephone system or  
34 other electronic means without cost to the employee.

35 (7) In addition to the fees prohibited under paragraphs  
36 (5) and (6), an employer may not use a payroll card account  
37 that charges fees to the employee for any of the following:

38 (i) The application, initiation or privilege of  
39 participating in the payroll card program.

40 (ii) The issuance of the initial payroll card.

41 (iii) The issuance of one replacement card per  
42 calendar year upon request of the employee.

1           (iv) The transfer of wages, salary, commissions or  
2           other compensation from the employer to the payroll card  
3           account.

4           (v) Purchase transactions at the point of sale.

5           (8) The funds in a payroll card account shall not  
6           expire. If a payroll card has an expiration date during the  
7           period when wages, salary or other compensation are applied  
8           to the payroll card account by the employer and for 60 days  
9           after the last transfer of wages, salary, commissions or  
10           other compensation to the account, the employee shall be  
11           provided a replacement card without cost prior to the  
12           expiration date, unless prior to that date the account  
13           becomes subject to the custody and control of the  
14           Commonwealth under Article XIII.1 of the act of April 9, 1929  
15           (P.L.343, No.176), known as The Fiscal Code, or pursuant to  
16           the unclaimed property or escheat law of another state, the  
17           District of Columbia or a territory of the United States.

18           (9) The employer shall honor an employee's written or  
19           electronic request to change the employee's method of  
20           receiving wages from a payroll card account to direct deposit  
21           or negotiable check. The change shall take effect as soon as  
22           practicable, but no later than the first payday after 14 days  
23           from receipt by the employer of the employee's request and  
24           any information necessary to implement the change.

25           (10) Nothing in this section may be construed to preempt  
26           or override the terms of any collective bargaining agreement  
27           with respect to the methods by which an employer provides  
28           payment of wages, salary, commissions or other compensation  
29           to employees.

33           An authorization for the payment of wages, salaries or other  
34           compensation by means of a payroll card account made prior to  
35           the effective date of section 2.1 of the act shall remain valid  
36           until the employee requests a change of payment method in  
37           accordance with section 2.1(9) of the act.
