5 Section 1. Short title.

6 This act shall be known and may be cited as the  
7 Detoxification Bed Registry Act.

8 Section 2. Definitions.

9 The following words and phrases when used in this act shall  
10 have the meanings given to them in this section unless the  
11 context clearly indicates otherwise:

12 "Bed registry." The detoxification bed registry established  
13 under this act.

14 "Department." The Department of Drug and Alcohol Programs of  
15 the Commonwealth.

16 "Licensed provider." A hospital-based detoxification or  
17 rehabilitation treatment program licensed to provide care for  
18 substance use disorder or a licensed nonhospital residential  
19 detoxification facility.

20 Section 3. Registry.

21 (a) Development.--The department shall develop and  
22 administer an Internet-based detoxification bed registry to  
23 collect, aggregate and display information about available beds  
24 at a licensed provider's detoxification and rehabilitation  
25 facility for the treatment of individuals in need of  
26 detoxification.

27 (b) Contents.--The bed registry shall include, but not be  
28 limited to, the following:

29 (1) Descriptive information for licensed providers in  
30 this Commonwealth, including contact information for each  
31 licensed provider.

32 (2) Real-time information updated at least daily  
33 regarding the number of beds available at a licensed  
34 provider's detoxification and rehabilitation facility and,  
35 for each available bed, the type of patient that may be  
36 admitted, the level of security provided and other

1 information that may be necessary to allow for the  
2 identification of appropriate licensed providers for the  
3 treatment of individuals in need of detoxification.

4 (3) A search function to identify available beds that  
5 are appropriate for the treatment of individuals experiencing  
6 a substance abuse emergency.

7 (c) Participation requirement.--A licensed provider shall  
8 participate in the bed registry established under this act and  
9 shall designate an employee to report information for inclusion  
10 in the bed registry. The designated employee shall serve as a  
11 point of contact for addressing requests for information related  
12 to data reported to the bed registry. The designated employee  
13 shall update daily the information reported to the bed registry.

14 (d) Licensed provider requirements.--In order to be eligible  
15 to access the registry, a licensed provider must:

16 (1) submit the information specified under subsection

17 (b) to the bed registry, including providing daily real-time  
18 information; or

19 (2) arrange for the licensed provider's contact  
20 information to be monitored and accessed at any time in  
21 accordance with the department's regulations promulgated  
22 under section 4.

23 (e) Private contracting.--The department may enter into a  
24 contract with a private entity for the development and  
25 administration of the bed registry.

26 Section 4. Regulations.

27 The department shall promulgate regulations necessary to  
28 implement this act.

29 Section 5. Effective date.

30 This act shall take effect in 60 days.
