

## AMENDMENTS TO HOUSE BILL NO. 1402

1 Amend Bill, page 1, line 3, by striking out the period after

2 "Highway" and inserting

3 ; designating a bridge on that portion of State Route 533 over

4 Muddy Run, Southampton Township, Franklin County, as the

5 Private First Class Dana Edward Diehl Memorial Bridge; and

6 designating a bridge on that portion of State Route 1004 over

7 the Conococheague Creek, Greene Township, Franklin County, as

8 the Private Charles W. "Bill" Roher Memorial Bridge.

9 Amend Bill, page 2, by inserting between lines 14 and 15

10 Section 2. Private First Class Dana Edward Diehl Memorial

11 Bridge.

12 (a) Findings.--The General Assembly finds and declares as  
13 follows:

14 (1) Private First Class Dana Edward Diehl, a native of  
15 Shippensburg, lived most of his life a few miles from the  
16 bridge over Muddy Run. He crossed over the bridge on Sunday  
17 mornings traveling to church, spent many hours fishing with  
18 his father along Muddy Run and cooled off in the stream with  
19 his family during hot summer days.

20 (2) Private First Class Diehl graduated from  
21 Shippensburg Area Senior High School in 1967. During high  
22 school, he was a member of the wrestling team and active in  
23 Boy Scout Troop No. 251.

24 (3) Private First Class Diehl honorably served his  
25 country as a medical specialist with the 25th Infantry  
26 Division, 3rd Squadron, 4th Cavalry, Headquarters Troop.

27 (4) On December 10, 1968, in Hau Nghia Province, South  
28 Vietnam, Private First Class Diehl was killed when the  
29 vehicle in which he was riding was struck by an explosive  
30 device.

31 (b) Designation.--The bridge located on State Route 533 over  
32 Muddy Run in Southampton Township, Franklin County, is  
33 designated the Private First Class Dana Edward Diehl Memorial  
34 Bridge.

35 (c) Signs.--The Department of Transportation shall erect and  
36 maintain appropriate signs displaying the name of the bridge to  
37 traffic in both directions on the bridge.

1 Section 3. Private Charles W. "Bill" Roher Memorial Bridge.

2 (a) Findings.--The General Assembly finds and declares as  
3 follows:

4 (1) Private Charles W. "Bill" Roher, a native of  
5 Chambersburg, served in the United States Army from April 19,  
6 1943, to March 28, 1945.

7 (2) Private Charles W. "Bill" Roher was a highly  
8 decorated veteran of World War II, having earned the Purple  
9 Heart, Bronze Star, Combat Infantry Badge, World War II  
10 Victory Medal, American Campaign Medal, European Theater of  
11 War Ribbon with one star, Good Conduct Medal, Marksman Badge  
12 with rifle bar and Glider Badge.

13 (b) Designation.--The bridge on State Route 1004 over the  
14 Conococheague Creek in Greene Township, Franklin County, is  
15 designated the Private Charles W. "Bill" Roher Memorial Bridge.

16 (c) Signs.--The Department of Transportation shall erect and  
17 maintain appropriate signs displaying the name of the bridge to  
18 traffic in both directions on the bridge.
