22 § 7006. Parking violations.

23 (a) General rule.--The provisions of this section shall be
24 applicable to enforcement of State and local parking laws in
25 cities of the second class by the use of automated license plate
26 reader systems.

27 (b) Service by mail.--In addition to other methods of

1 service, notices or citations with respect to violations of
2 State or local parking laws detected by the use of automated
3 license plate reader systems may be served by first class mail.
4 The following provisions shall apply to service by mail under
5 this subsection:

6 (1) The notice of violation or citation must be mailed
7 within two business days of the commission of the violation
8 to the address of the registered owner.

9 (2) Notice of violation or citation must be sent by
10 first class mail.

11 (3) A manual or automatic record of the mailing prepared
12 in the ordinary course of business shall be prima facie
13 evidence of mailing and shall be admissible in any judicial
14 or administrative proceeding as to the facts contained in it.

15 (4) For purposes of effectuating the powers set forth in
16 this subsection, a parking authority in the city of the
17 second class shall be deemed an authorized user of the
18 Pennsylvania Justice Network under section 6328 (relating to
19 admissibility of department records).

20 (c) Cities of the second class.--In cities of the second
21 class, the display on any parked motor vehicle of a registration
22 plate which is obscured in any manner shall be deemed to be a
23 parking violation for purposes of section 6301 (relating to
24 prosecutions under local ordinances superseded by title) and may
25 be enforced by a parking authority in the cities of the second
26 class.

27 (d) Evidence of violation.--A certificate or a facsimile of
28 a certificate based upon inspection of captured data sworn to or
29 affirmed by an employee of the government entity shall be prima
30 facie evidence of the facts contained in the certificate.
31 Captured data evidencing a violation of a State or local parking
32 law shall be admissible in any judicial or administrative
33 proceeding to adjudicate the liability for the violation.
