13 § 501. Definitions.

14 The following words and phrases when used in this chapter
15 shall have the meanings given to them in this section unless the
16 context clearly indicates otherwise:

17 "Commonwealth agency." Any office, authority, board,
18 multistate agency or commission of the executive branch, an
19 independent agency or a State-affiliated entity. The term
20 includes any of the following:

21 (1) The Governor's Office.

22 (2) The Office of Attorney General.

23 (3) The Department of the Auditor General.

24 (4) The Treasury Department.

25 (5) An organization established by the Constitution of
26 Pennsylvania, a statute or an executive order which performs
27 or is intended to perform an essential government function.

28 (6) A legislative agency.

29 (7) A judicial agency.

30 "Independent agency." Any office, authority, board or agency
31 of the Commonwealth that is not subject to the policy,

1 supervision or control of the Governor.

2 "Judicial agency." Any of the following:

3 (1) The Supreme Court of Pennsylvania.

4 (2) The Superior Court of Pennsylvania.

5 (3) The Commonwealth Court of Pennsylvania.

6 (4) The Administrative Office of Pennsylvania Courts.

7 "Legislative agency." As defined in section 102 of the act
8 of February 14, 2008 (P.L.6, No.3), known as the Right-to-Know
9 Law.

10 "State-affiliated agency." Any of the following:

11 (1) The Pennsylvania Gaming Control Board.

12 (2) The Pennsylvania Housing Finance Agency.

13 (3) The State System of Higher Education.

24 (1) The State Treasurer shall provide on the
25 transparency portal an analysis of the General

34 able to delineate expenditures under this subparagraph by
35 appropriation paid out of the General Fund by the
36 Commonwealth agency that made the expenditure.

37 (iv) General Fund revenues, including information
38 relating to the difference between estimated revenues
39 provided by the Independent Fiscal Office under section
40 605-B of the act of April 9, 1929 (P.L.177, No.175),
41 known as The Administrative Code of 1929, for the given

1 fiscal year and actual revenues collected. The Treasury
2 Department shall also include a graph comparing changes
3 within the General Fund revenues and General Fund
4 expenditures starting with the 2018-2019 fiscal year.

5 (2) In order to assist the State Treasurer in compiling
6 the information required under this subsection for the
7 analysis of the General Fund, each Commonwealth agency shall
8 provide the information to the Treasury Department in a file
9 format specified by the Treasury Department through interface
10 files.
