If by the first day of the fiscal year the 15 General Assembly has not enacted a balanced operating budget, 16 including bills that raise sufficient revenue as provided under 17 18 this subsection, members of the General Assembly shall not be entitled to receive salary or reimbursement for expenses until 19 the balanced operating budget is enacted into law. 20 21 (b) The following shall apply: (1) The balanced operating budget passed by the General_ 22 Assembly, consisting of the general appropriation bill, other 23 appropriation bills, nonpreferred appropriation bills, statutory 24 authorizations and implementation bills, shall be supported by 25 26 revenues which recur annually. (2) If the balanced operating budget proposes to use 27 nonrecurring revenues to pay for recurring costs, the balanced 28 operating budget shall contain a plan to replace the 29 30 nonrecurring revenues with recurring revenues and shall outline in detail reductions to expenditures necessary to bring future 31 32 <u>budgets into balance.</u> (3) The balanced operating budget submitted to the Governor 33 34 by the General Assembly shall include sufficient appropriations 35 and authorizations for: (i) The continuation of service required under current law. 36 37 (ii) Federal mandates.
