

## AMENDMENTS TO SENATE BILL NO. 472

1 Amend Bill, page 1, lines 12 through 14, by striking out all  
2 of said lines and inserting

3 Section 2. The definitions of "medical emergency" and  
4 "minor" in section 52A01 of Title 35, added November 2, 2016  
5 (P.L.983, No.125), are amended and the section is amended by  
6 adding a definition to read:

7 Amend Bill, page 2, by inserting between lines 2 and 3

8 "Health care facility." The term shall have the same meaning  
9 as provided in section 103 of the act of July 19, 1979 (P.L.130,  
10 No.48), known as the Health Care Facilities Act.

12 Amend Bill, page 2, by inserting between lines 6 and 7

13 "Minor." An individual under 18 years of age. The term  
14 excludes [an individual] a minor who is [emancipated by:

- 15 (1) marrying;  
16 (2) entering the armed forces of the United States;  
17 (3) being employed and self-sustaining; or  
18 (4) otherwise being independent from the care and  
19 control of the individual's parent, guardian or custodian.]:  
20 (1) married or has been married;  
21 (2) pregnant or has been pregnant;  
22 (3) a member of the armed forces of the United States;

23 or

24 (4) legally emancipated.

27 Amend Bill, page 4, line 7, by inserting a bracket before  
28 "Obtain"

29 Amend Bill, page 4, line 7, by inserting after "Obtain"

7 Amend Bill, page 4, lines 26 through 28, by striking out "]  
8 individual" in line 26, all of line 27 and "the" in line 28

9 Amend Bill, page 4, line 28, by striking out the comma after  
10 "adult"

11 Amend Bill, page 4, line 30, by striking out the bracket  
12 before "minor's"

13 Amend Bill, page 4, line 30; page 5, line 1; by striking out  
14 the bracket in line 30 on page 4 and "individual's" in line 1 on  
15 page 5

16 Amend Bill, page 5, by inserting between lines 14 and 15

17 (3) The medical treatment is rendered while the minor or  
18 individual remains admitted to a licensed health care  
19 facility or remains in observation status in a licensed  
20 health care facility.

21 (4) The prescriber is continuing a treatment initiated  
22 by another member of the prescriber's practice, the  
23 prescriber who initiated the treatment followed the  
24 procedures outlined in subsection (a) and the prescriber who  
25 is continuing the treatment is not changing the therapy in  
26 any way other than dosage.
