(a) General rule. -- Under section 2413 of the act of March 4, 18 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, the 19 Office of the State Fire Commissioner shall establish quidelines 20 for the use of money deposited into the Online Training Educator 21 22 and Training Reimbursement Account and dedicated for the purposes of developing, delivering and sustaining training 23 programs for firefighters. The quidelines shall provide that the 24 money be used for online training for volunteer and career 25 26 firefighters and shall include, at a minimum, the following: (1) Participation in the training shall be on a 27 28 voluntary basis. 29 (2) The training shall be offered free of charge. 30 (3) The training shall be incorporated into the Train PA 31 system. (b) Prioritization. -- In establishing online training 32 courses, the commissioner shall prioritize specific topics. 33
