

## AMENDMENTS TO HOUSE BILL NO. 163

1 Amend Bill, page 1, lines 1 through 8, by striking out all of  
2 said lines and inserting

3 Repealing the act of May 1, 1913 (P.L.155, No.104), entitled "An  
4 act regulating the letting of certain contracts for the  
5 erection, construction, and alteration of public buildings,"  
6 and making related repeals.

7 Amend Bill, page 1, lines 11 through 20; pages 2 through 5,  
8 lines 1 through 30; page 6, lines 1 through 18; by striking out  
9 all of said lines on said pages and inserting

10 Section 1. The act of May 1, 1913 (P.L.155, No.104),  
11 referred to as the Separations Act, is repealed:

12 [AN ACT

13 Regulating the letting of certain contracts for the erection,  
14 construction, and alteration of public buildings.

15 Section 1. Be it enacted, &c., That hereafter in the  
16 preparation of specifications for the erection, construction,  
17 and alteration of any public building, when the entire cost of  
18 such work shall exceed four thousand dollars, it shall be the  
19 duty of the architect, engineer, or other person preparing such  
20 specifications, to prepare separate specifications for the  
21 plumbing, heating, ventilating, and electrical work; and it  
22 shall be the duty of the person or persons authorized to enter  
23 into contracts for the erection, construction, or alteration of  
24 such public buildings to receive separate bids upon each of the  
25 said branches of work, and to award the contract for the same to  
26 the lowest responsible bidder for each of said branches.

27 Every contract for the construction, reconstruction,  
28 alteration, repair, improvement or maintenance of public works  
29 shall comply with the provisions of the act of March 3, 1978  
30 (P.L.6, No.3), known as the "Steel Products Procurement Act."

31 Section 2. All acts or parts of acts inconsistent herewith  
32 are hereby repealed.]

33 Section 2. The following acts and parts of acts are  
34 repealed:

35 (1) Section 1805 of the act of June 24, 1931 (P.L.1206,

1 No.331), known as The First Class Township Code.

2 (2) Section 3107 of the act of May 1, 1933 (P.L.103,  
3 No.69), known as The Second Class Township Code.

4 (3) Section 751 of the act of March 10, 1949 (P.L.30,  
5 No.14), known as the Public School Code of 1949.

6 (4) Section 5 of the act of May 27, 1953 (P.L.244,  
7 No.34), entitled "An act relating to and regulating the  
8 contracts of incorporated towns and providing penalties."

9 (5) Section 2517 of the act of July 28, 1953 (P.L.723,  
10 No.230), known as the Second Class County Code.

11 (6) Section 2317 of the act of August 9, 1955 (P.L.323,  
12 No.130), known as The County Code.

13 (7) The provisions of 8 Pa.C.S. § 1405.

14 (8) The provisions of 11 Pa.C.S. § 11909.

15 Section 3. Contracts, obligations and collective bargaining  
16 agreements entered into under the Separations Act are not  
17 affected nor impaired by the repeal of the act of May 1, 1913  
18 (P.L.155, No.104), referred to as the Separations Act.

19 Section 4. This act shall take effect immediately.
