Local Option. -- (a) In any municipality or any 6 part of a municipality where such municipality is split so that 7 each part thereof is separated by another municipality, an 8 election may be held, subject to subsection (c), not oftener than once in four years, to determine the will of the electors 9 with respect to the granting of liquor licenses to hotels, 10 restaurants, resort facilities and clubs, not oftener than once 11 12 in four years, to determine the will of the electors with 13 respect to the granting of liquor licenses to public venues, to performing arts facilities, to continuing care retirement 14 communities, to hotels located on property owned by an 15 accredited college or university, to privately-owned private 16 golf courses or to privately-owned public golf courses, not 17 oftener than once in four years, to determine the will of the 18 19 electors with respect to the granting of licenses to retail dispensers of malt and brewed beverages, not oftener than once 20 21 in four years, to determine the will of the electors with 22 respect to granting of licenses to wholesale distributors and 23 importing distributors, not more than once in two years, to determine the will of the electors with respect to the granting 24 25 of club liquor licenses or club retail dispenser licenses to incorporated units of national veterans' organizations, not 26 27 oftener than once in two years to determine the will of the electors with respect to the granting of special occasion 28 29 permits to qualified organizations, not more than once in four 30 years, to determine the will of the electors with respect to the establishment, operation and maintenance by the board of 31 32 Pennsylvania liquor stores, within the limits of such 33 municipality or part of a split municipality, or not more than 34 once in two years, to determine the will of the electors with 35 respect to the granting of liquor licenses to ski resort 36 facilities, under the provisions of this act: Provided, That an 37 election on the question of establishing and operating a State

liquor store shall be initiated only in those municipalities, or that part of a split municipality that shall have voted against the granting of liquor licenses; and that an election on the question of granting wholesale distributor and importing 5 distributor licenses shall be initiated only in those municipalities or parts of split municipalities that shall have at a previous election voted against the granting of dispenser's 7 licenses. Except for a municipality or part of a split 9 municipality located in a county of the second class A, whenever electors equal to at least twenty-five per centum of the highest 10 11 vote cast for any office in the municipality or part of a split 12 municipality at the last preceding general election shall file a petition with the county board of elections of the county for a 13 referendum on the question of granting any of said classes of 14 15 licenses or the establishment of Pennsylvania liquor stores, the 16 said county board of elections shall cause a question to be 17 placed on the ballots or on the voting machine board and 18 submitted at any election. In a county of the second class A, whenever electors equal to at least twenty-five per centum of 19 20 the highest vote cast for any office in a municipality or part 21 of a split municipality at the last preceding general election, 22 or whenever five hundred electors of a municipality or part of a 23 split municipality, whichever is less, sign a petition for a 24 referendum on the question of granting any of the said classes of licenses or the establishment of Pennsylvania liquor stores 25 26 and file the petition with the county board of elections, the 27 said county board of elections shall cause a question to be 28 placed on the ballots or on the voting machine board and 29 submitted at any election. Separate petitions must be filed for each question to be voted on.
