13 (c) Postinfancy action.--

14 (1) If an individual entitled to bring a civil action
 15 arising from sexual abuse is 18 years of age or older at the
 16 time the cause of action accrues, the individual may commence
 17 an action for damages regardless of whether the individual
 18 files a criminal complaint regarding the sexual abuse or the
 19 age of the individual.

20 (2) For the purpose of this subsection, the term "sexual
 21 abuse" shall include actions that constitute an offense under
 22 the following provisions of 18 Pa.C.S. (relating to crimes
 23 and offenses):

24 Section 3011(a) (relating to trafficking in
 25 individuals).

26 Section 3012 (relating to involuntary servitude) as
 27 it relates to sexual servitude.

28 Section 3121 (relating to rape).

29 Section 3123 (relating to involuntary deviate sexual
 30 intercourse).

1 Section 3124.1 (relating to sexual assault).
2 Section 3124.2 (relating to institutional sexual
3 assault).
4 Section 3125 (relating to aggravated indecent
5 assault).
6 Section 4302 (relating to incest).

7 (d) Revival of claims.--The following shall apply:

8 (1) Notwithstanding subsection (b) or any other
9 provision of law, for an individual entitled to bring a civil
10 action arising from childhood sexual abuse where the
11 limitation period has expired, the individual shall have an
12 additional period of two years from the effective date of
13 this subsection to commence an action.

14 (2) Notwithstanding subsection (c) or any other
15 provision of law, for an individual who is 18 years of age or
16 older and entitled to bring a civil action arising from
17 sexual abuse where the limitation period has expired, the
18 individual shall have an additional period of two years from
19 the effective date of this subsection to commence an action.
