9 (e) This section shall apply to school years beginning after
10 the regulations are promulgated by the Advisory Health Board
11 under subsection (a)(2).

12 (f) As used in this section, the following words and phrases
13 shall have the meanings given to them in this subsection unless
14 the context clearly indicates otherwise:

15 "Nonpublic school." As defined in section 922.1-A.

16 "School entity." A school district, charter school, regional
17 charter school, cyber charter school, intermediate unit or area
18 career and technical school.
