24 (d) Allocation to Catastrophic Medical and Rehabilitation
25 Fund.--Twenty-five percent of the money in the Emergency Medical
26 Services Operating Fund shall be allocated to a Catastrophic
27 Medical and Rehabilitation Fund for victims of trauma and to
28 carry out the provisions of Chapter 75A (relating to emergency
29 responder mental wellness and stress management). After the
30 exhaustion of all alternative financial resources, other than
31 those excluded by the department from consideration, the
32 catastrophic fund shall be available for the purchase of
33 medical, rehabilitation and attendant care services for trauma
34 victims and may be made available for the purchase of supportive
35 services such as respite care and counseling services for the
36 family or household members of trauma victims. The department
37 may, by regulation, prioritize the distribution of funds by and
38 within classification of traumatic injury.
