4 (a.2) Upon receipt of the report and recommendation, the  
5 board shall develop a proposed implementation plan. The proposed  
6 implementation plan shall include the following information:

7 (1) Description of the proposal to exercise powers under  
8 section 2006-A(a) (13.2).

9 (2) Rationale, goals and objectives of the proposal to  
10 exercise powers under section 2006-A(a) (13.2).

11 (3) Method for evaluating achievement of goals and  
12 objectives.

13 (4) Relation of the proposal to the mission and strategic  
14 plan of the institution or college and system as a whole.

15 (5) Impacts on academic programs, nonacademic units and  
16 accreditation.

17 (6) Impacts on student, faculty and staff.

18 (7) Impacts on the community.

19 (8) Impacts on shared governance.

20 (9) Before and after organizational charts for all impacted  
21 institutions or colleges.

22 (10) Information included in the chancellor's report and  
23 recommendation under subsection (a.1).

24 (11) Timeline for implementation plan.

25 (a.3) Within fourteen (14) days after issuance of the  
26 proposed implementation plan

38 (a.4) The board shall consult with stakeholders, including  
39 faculty, staff, students and administrators, and hold at least  
40 two (2) public hearings as part of the public comment period  
41 under subsection (a.3) (2). After the public comment period and  
42 before any action may be taken pursuant to section 2006-A(a)  
43 (13.2), the board shall consider comments made by stakeholders

1 during the public comment period and present a final  
2 implementation plan at a public meeting subject to the approval  
3 by a majority of the board. If the board votes to approve the  
4 implementation plan, the board shall, within fourteen (14) days,  
5 transmit a copy of the final implementation plan to the  
6 following:

8 (a.5) The timeline for implementation to be completed as  
9 described in the final implementation plan shall be no earlier  
10 than 12 (twelve) months from the date of the issuance of the  
11 proposed implementation plan.

13 affiliate, dissolve or close" and inserting  
14 or affiliate
