8 Section 1. Section 432.1(b)(1)(vii) and (viii) and (j) of
9 the act of April 9, 1929 (P.L.177, No.175), known as The
10 Administrative Code of 1929, are amended, subsection (b)(1) is
11 amended by adding a subparagraph and the section is amended by
12 adding a subsection to read:

13 Section 432.1. State Geospatial Coordinating Board.--* * *
14 (b) (1) The State Geospatial Coordinating Board shall
15 consist of the following members:

16 * * *

17 (vi.1) The Secretary of Agriculture or a designee.

18 (vii) Three members appointed by the President pro tempore
19 of the Senate in consultation with the Majority Leader and
20 Minority Leader of the Senate. One member shall be a
21 representative of a municipal authority. [One member] Two
22 members shall be [an elected] local government [official
23 representing a rural community. One member shall be an elected
24 local government official representing a suburban community]
25 officials or employees.

26 (viii) Three members appointed by the Speaker of the House
27 of Representatives in consultation with the Majority Leader and
28 Minority Leader of the House of Representatives. One member
29 shall be a local [elected] government official or employe
30 representing an urban community. One member shall be an employe
31 of a county emergency management agency. One member shall be an
32 individual with expertise in geospatial technology.

33 * * *

34 (f.1) The board may, with the approval of the Governor,
35 appoint an executive director who shall serve at the pleasure of
36 the board. The selection and removal of the executive director

1 shall be made by a simple majority of the voting members of the
2 board that constitute a quorum. Compensation for the executive
3 director shall be set by a vote of a majority of the board
4 members identified in subsection (b)(1)(i), (ii), (iii), (iv),
5 (v), (vi) and (vi.1), subject to the approval of the Executive
6 Board. Funding for the executive director's compensation shall
7 be evenly apportioned amongst all of the Commonwealth agencies
8 represented by members in subsection (b)(1)(i), (ii), (iii),
9 (iv), (v), (vi) and (vi.1) and administered by the Governor's
10 Budget Office. The executive director shall be qualified for the
11 duties of the position, as determined by the board, and shall
12 conduct the work of the board under the board's direction and
13 supervision. No current member of the board may serve as the
14 executive director. The executive director's appointment shall
15 not continue beyond the expiration of this section. The
16 executive director shall be subject to the same policies and
17 procedures as employees of the Office of Administration.
