1 Amend Bill, page 1, line 15, by inserting after "Assembly"

7 (3) The annual salaries for individuals subject to 42  
8 Pa.C.S. § 1741(a)(1) or (2) (relating to compensation of  
9 judges) may not be increased by a cost-of-living adjustment  
10 under 42 Pa.C.S. § 1741(b) for the annual period beginning  
11 January 1, 2021, and ending December 31, 2021. Notice of the  
12 provisions of this subsection shall be transmitted to the  
13 Legislative Reference Bureau for publication in the  
14 Pennsylvania Bulletin prior to December 1, 2020.

18 Section 2. The act is amended by adding a section to read:  
19 Section 5.3. Cost-of-living adjustment hiatus.

20 (a) General rule.--The salary of salaried officers of the  
21 Commonwealth, except for an individual subject to sections  
22 2.1(i)(2) and (3), 3(e)(2), 4(d)(2) and (d.1)(2), may not be  
23 increased by a cost-of-living adjustment for the period  
24 beginning January 1, 2021, and ending December 31, 2021.

25 (b) Definitions.--As used in this section, the following  
26 words and phrases shall have the meanings given to them in this  
27 subsection unless the context clearly indicates otherwise:  
28 "Salaried officers of the Commonwealth." The term shall have  
29 the same meaning as in section 16(a) of Article V of the  
30 Constitution of Pennsylvania.

31 Section 3. The following shall apply:

32 (1) Except as provided under paragraph (2), the  
33 provisions of this act shall not be severable.

34 (2) The amendment of section 2.1(i) of the act and

1 section 4 of this act shall be severable from the remainder  
2 of this act.

3 Section 4. Repeals are as follows:

4 (1) The General Assembly declares that the repeal under  
5 paragraph (2) is necessary for the amendment of section  
6 2.1(i) of the act.

7 (2) 42 Pa.C.S. § 1741(b) is repealed insofar as it is  
8 inconsistent with the amendment of section 2.1(i) of the act.
