4 (c) Notice.--Upon the initial appropriation of sufficient  
5 funds to carry out the provisions of this act or a determination  
6 by the department that sufficient funds are available from  
7 another existing source to carry out the provisions of this act,  
8 the department shall transmit notice of the appropriation to the  
9 Legislative Reference Bureau for publication in the Pennsylvania  
10 Bulletin.
