11 (b) [The application] An application for a qualified elector  
12 under subsection (a) shall contain the following information:  
13 Home residence at the time of entrance into actual military  
14 service or Federal employment, length of time a citizen, length  
15 of residence in Pennsylvania, date of birth, length of time a  
16 resident of voting district, voting district if known, party  
17 choice in case of primary, name and, for a military elector, his  
18 stateside military address, FPO or APO number and serial number.  
19 Any elector other than a military elector shall in addition  
20 specify the nature of his employment, the address to which  
21 ballot is to be sent, relationship where necessary, and such  
22 other information as may be determined and prescribed by the  
23 Secretary of the Commonwealth. When such application is received  
24 by the Secretary of the Commonwealth it shall be forwarded to  
25 the proper county board of election.

26 (b.1) An application for a qualified elector other than  
27 under subsection (a) shall contain the following information:  
28 Date of birth, length of time a resident of voting district,  
29 voting district if known, party choice in case of primary and  
30 name. The elector shall in addition specify the nature of his or  
31 her employment, the address to which ballot is to be sent,  
32 relationship where necessary, and other information as may be  
33 determined and prescribed by the Secretary of the Commonwealth.

1 When the application is received by the Secretary of the  
2 Commonwealth it shall be forwarded to the proper county board of  
3 election.
