

## AMENDMENTS TO SENATE BILL NO. 952

4 "Veteran." The term includes:

5 (1) An individual who served, as evidenced by the  
6 veteran's discharge papers or separation documents, or  
7 hereafter serves:

8 (i) in the armed forces of the United States,  
9 including a reserve component and National Guard,  
10 completed initial contractual military service obligation  
11 and their last discharge or release was under conditions  
12 other than dishonorable;

13 (ii) in the armed forces of the United States,  
14 including a reserve component and National Guard, served  
15 during a period of war or armed conflict, completed a  
16 tour of active duty for purposes other than training, was  
17 released from that period of active duty under conditions  
18 other than dishonorable and continues to serve; or

19 (iii) in the armed forces of the United States,  
20 including a reserve component and National Guard,  
21 completed an initial contractual military service  
22 obligation and continues to serve.

23 (2) An active duty member of the armed forces of the  
24 United States who is completing a tour of active duty that is  
25 three years or more and is within 90 days of an approved  
26 discharge or release, as evidenced by documentation of the  
27 projected discharge or release from active duty under  
28 conditions other than dishonorable.

28 (2) An active duty member of the armed forces of the  
29 United States who is completing a tour of active duty that is  
30 three years or more and is within 90 days of an approved  
31 discharge or release, as evidenced by documentation of the  
32 projected discharge or release from active duty under  
33 conditions other than dishonorable.
