1 Amend Bill, page 1, lines 8 through 18, by striking out all
2 of said lines and inserting

3 Section 2. Definitions.

4 The following words and phrases when used in this act shall
5 have the meanings given to them in this section unless the
6 context clearly indicates otherwise:

7 "COVID-19." The novel coronavirus as identified in the
8 Governor's Proclamation of Disaster Emergency issued on March 6,
9 2020, published at 50 Pa.B. 1644 (March 21, 2020).

10 "COVID-19 vaccine." A vaccine for COVID-19 that has received
11 an emergency-use authorization from the United States Food and
12 Drug Administration.

13 Section 3. Administration.

14 Notwithstanding any other act to the contrary, an individual
15 authorized to administer a COVID-19 vaccine by the United States
16 Department of Health and Human Services under the Seventh
17 Amendment to Declaration Under the Public Readiness and
18 Emergency Preparedness Act for Medical Countermeasures Against
19 COVID-19 shall be permitted to administer vaccines in this
20 Commonwealth, including:

21 (1) A midwife, paramedic, advanced or intermediate
22 emergency medical technician, physician assistant,
23 respiratory therapist, dentist, podiatrist, optometrist or
24 veterinarian licensed, registered or certified to practice
25 under the laws of this Commonwealth.

26 (2) A physician, advanced practice registered nurse,
27 registered nurse, practical nurse, pharmacist, pharmacy
28 intern, midwife, paramedic, advanced or intermediate
29 emergency medical technician, respiratory therapist, dentist,
30 physician assistant, podiatrist, optometrist or veterinarian
31 who has held an active license, registration or certification
32 under the laws of this Commonwealth within the last five
33 years, which is inactive, expired or lapsed, if the license,
34 registration or certification was active and in good standing
35 prior to the date it went inactive, expired or lapsed and was
36 not revoked by the licensing authority, surrendered while
37 under suspension, discipline or investigation by a licensing
38 authority or surrendered following an arrest, and the

1 individual is not on the List of Excluded
2 Individuals/Entities maintained by the Office of Inspector
3 General.

4 (3) A medical, nursing, pharmacy, pharmacy intern,
5 midwife, paramedic, advanced or intermediate emergency
6 medical technician, physician assistant, respiratory therapy,
7 dental, podiatry, optometry or veterinary student with
8 appropriate training in administering vaccines as determined
9 by his or her school or training program, and under the
10 direct supervision of a currently practicing health care
11 professional who is licensed, registered or certified in this
12 Commonwealth and who is experienced in administering
13 intramuscular injections.

14 Section 4. Requirements.

15 Individuals who gain authorization to administer COVID-19
16 vaccines under this act are subject to the following
17 requirements:

18 (1) Individuals must have documentation showing:

19 (i) Current basic life support certification,
20 commonly known as basic cardiopulmonary resuscitation or
21 CPR.

22 (ii) Completion of an immunization training program
23 endorsed or provided by the Centers for Disease Control
24 and Prevention, the Accreditation Council for Pharmacy
25 Education or any similar training approved by the
26 Secretary of Health that, at a minimum, includes:

27 (A) Hands-on injection technique.

28 (B) Clinical evaluation of indications and
29 contraindications of vaccines.

30 (C) Recognition and treatment of emergency
31 reactions to vaccines.

32 (2) (Reserved).

33 Section 5. Observation period.

34 Health care professionals and students who gain authorization
35 to administer COVID-19 vaccines under this act must have
36 documentation of an observation period by a currently practicing
37 health care professional experienced in administering
38 intramuscular injections, and for whom administering
39 intramuscular injections is in their ordinary scope of practice,
40 who confirms competency of the health care provider or student
41 in administration of COVID-19 vaccines.

42 Section 6. Recordkeeping.

43 Health care professionals and students who gain authorization
44 to administer COVID-19 vaccines under this act must comply with
45 recordkeeping and reporting requirements as determined by the
46 Secretary of Health.

47 Section 7. Expiration.

48 This act shall expire 60 days after the termination of the
49 Governor's COVID-19 emergency declaration order, or December 31,
50 2022, whichever is earlier.

51 Section 8. Effective date.

1 This act shall take effect immediately.
