1 Amend Bill, page 1, by inserting between lines 6 and 7

2 (A00535)

3 "Affected county." Any of the following:

4 (1) A county of the second class A.

5 (2) A county of the third class which has entered into  
6 an intergovernmental cooperation agreement to oversee the  
7 COVID-19 response in a county of the second class A.

8 Amend Bill, page 1, by inserting between lines 12 and 13

9 (A00535)

10 "Mass vaccination site." Any of the following:

11 (1) A location in an affected county designed to quickly  
12 and efficiently provide COVID-19 vaccinations on a mass scale  
13 to the general public.

14 (2) The term includes a location under paragraph (1),  
15 including a gymnasium, shopping center, parking lot, senior  
16 center, house of worship, library, fire station or other  
17 facility not typically utilized for the delivery of medical  
18 services.

19 (3) The term does not include the following:

20 (i) A location under paragraph (1) which is a  
21 hospital, nursing home, assisted living facility, skilled  
22 nursing facility, pharmacy or other facility where the  
23 delivery of medical services is typically performed or an  
24 auxiliary location utilized by a hospital, health care  
25 system or pharmacy to provide COVID-19 vaccinations with  
26 COVID-19 vaccines obtained by the respective hospital,  
27 health care system or pharmacy.

28 (ii) A location under paragraph (1) primarily or  
29 exclusively providing COVID-19 vaccinations to  
30 individuals at their own place of employment, or to  
31 individuals in a specific field of employment, including  
32 teachers, agricultural workers, grocery store employees  
33 or other individuals deemed as essential workers.

34 (iii) A location under paragraph (1) primarily or  
35 exclusively providing COVID-19 vaccinations to  
36 individuals covered under a collective bargaining

1 agreement.

2 Amend Bill, page 2, by inserting between lines 46 and 47  
3 (A00535)

4 Section 6.1. Distribution of COVID-19 vaccines to a mass  
5 vaccination site.

6 The Department of Health shall deliver COVID-19 vaccines  
7 intended for use at a mass vaccination site in an affected  
8 county to the health department of the affected county, or the  
9 county health department overseeing the response to the COVID-19  
10 pandemic for the affected county. The governing board of each  
11 affected county shall have sole authority to designate a  
12 location or locations to be utilized as a mass vaccination site  
13 or sites within the county and shall coordinate with the  
14 appropriate county health department for the delivery and  
15 administration of COVID-19 vaccines at each mass vaccination  
16 site.
