

AMENDMENTS TO HOUSE BILL NO. 1154

1 Amend Bill, page 1, lines 16 through 18, by striking out "
2 in" in line 16, all of line 17 and "and," in line 18

3 Amend Bill, page 1, lines 25 through 28; page 2, lines 1
4 through 12; by striking out all of said lines on said pages and
5 inserting

6 Section 1. Section 406 of the act of April 12, 1951 (P.L.90,
7 No.21), known as the Liquor Code, is amended by adding a
8 subsection to read:

9 Amend Bill, page 3, by inserting between lines 6 and 7

10 (iii) A licensee that has an interior connection to a
11 grocery store, convenience store or department store.

12 Amend Bill, page 3, lines 20 through 24, by striking out all
13 of said lines and inserting

14 (5) A licensee selling prepared beverages or mixed drinks
15 for off-premises consumption shall prominently post a warning
16 sign in a manner that puts consumers on notice of the
17 restrictions on alcoholic beverages under 75 Pa.C.S. § 3809
18 (relating to restriction on alcoholic beverages), and that the
19 prepared beverages and mixed drinks packaged for sale by the
20 licensee are open containers and may only be transported by the
21 driver of a motor vehicle in the vehicle's trunk or in some
22 other area of the vehicle that is not occupied by the driver or
23 passengers.

24 (6) A prepared beverage or mixed drink for off premise
25 consumption must be affixed with a label identifying that the
26 product contains alcohol.

27 (7) As used in this subsection, the following words and
28 phrases shall have the meanings given to them in this paragraph
29 unless the context clearly indicates otherwise:

30 "Convenience store." A retail business that sells a range of
31 everyday items, including coffee, groceries, snack foods,
32 confectionery, soft drinks, tobacco products, over-the-counter

1 drugs, toiletries, gasoline and magazines.

2 "Department store." A retail establishment offering a wide
3 range of consumer goods in different areas of the store, which
4 may include food items.

5 "Grocery store." A retail business that primarily sells a
6 wide variety of fresh and packaged foods, beverages and other
7 items to be consumed or used off of the store premises.

8 "Transaction scan device." A device capable of deciphering,
9 in an electronically readable format, the information encoded on
10 the magnetic strip, chip or bar code of an identification card
11 under section 495(a).
