

## AMENDMENTS TO HOUSE BILL NO. 1264

1 Amend Bill, page 1, lines 5 through 18; page 2, lines 1  
2 through 30; page 3, lines 1 through 20; by striking out all of  
3 said lines on said pages and inserting

4 Section 1. Short title.

5 This act shall be known and may be cited as the COVID-19  
6 Pandemic Reporting, Response and Accountability Act.

7 Section 2. Definitions.

8 The following words and phrases when used in this act shall  
9 have the meanings given to them in this section unless the  
10 context clearly indicates otherwise:

11 "COVID-19." The novel coronavirus as identified in the  
12 Governor's proclamation of disaster emergency issued on March 6,  
13 2020, published at 50 Pa.B. 1644 (March 21, 2020).

14 "COVID-19 vaccine." A vaccine for COVID-19 that has received  
15 an emergency-use authorization from the United States Food and  
16 Drug Administration.

17 "Personal protective equipment." Gloves, respirators, face  
18 masks, gowns, face shields, clothing or other protective  
19 equipment designed to be worn by individuals to prevent or  
20 contain contact with, or to prevent or control transmission of,  
21 a communicable illness or the pathogens that cause communicable  
22 illness.

23 Section 3. Administration.

24 No later than 90 days after the effective date of this  
25 section, the Department of General Services, in consultation  
26 with the Adjutant General of the Commonwealth, the Secretary of  
27 Health and the Director of the Pennsylvania Emergency Management  
28 Agency, shall submit a report to the President pro tempore of  
29 the Senate, the Majority Leader of the Senate, the Minority  
30 Leader of the Senate, the Speaker of the House of  
31 Representatives, the Majority Leader of the House of  
32 Representatives, the Minority Leader of the House of  
33 Representatives, the chairperson and minority chairperson of the  
34 State Government Committee of the Senate, the chairperson and  
35 minority chairperson of the State Government Committee of the  
36 House of Representatives, the chairperson and minority  
37 chairperson of the Agriculture and Rural Affairs Committee of

1 the Senate, the chairperson and minority chairperson of the  
2 Agriculture and Rural Affairs Committee of the House of  
3 Representatives, the chairperson and minority chairperson of the  
4 Veterans Affairs and Emergency Preparedness Committee of the  
5 Senate and the chairperson and minority chairperson of the  
6 Veterans Affairs and Emergency Preparedness Committee of the  
7 House of Representatives. The report shall include:

8 (1) A report of personal protective equipment and  
9 medical supplies purchased or acquired by the Commonwealth or  
10 its agencies in response to the COVID-19 pandemic and  
11 warehoused at the Farm Show Complex. The report under this  
12 paragraph must include the following:

13 (i) The types of personal protective equipment  
14 acquired.

15 (ii) The number of items of each type of personal  
16 protective equipment under subparagraph (i).

17 (iii) The number of items of each type of personal  
18 protective equipment which was distributed prior to the  
19 date of the report.

20 (iv) The number of items of each type of personal  
21 protective equipment which remains in the possession of  
22 the Commonwealth as of the date of the report.

23 (v) The amount and source of the money used to  
24 purchase personal protective equipment to address the  
25 COVID-19 pandemic.

26 (vi) The amount and source of personal protective  
27 equipment donated to, or otherwise acquired by, the  
28 Commonwealth at no cost to address the COVID-19 pandemic.

29 (vii) The country of origin or manufacture of each  
30 type of personal protective equipment under subparagraph  
31 (i).

32 (viii) The facilities utilized to store, maintain or  
33 warehouse the Commonwealth's stockpile of personal  
34 protective equipment other than the Farm Show Complex.

35 (ix) Measures taken to secure and protect the  
36 Commonwealth's stockpile of personal protective  
37 equipment, including, but not limited to, costs  
38 associated with security services and pest control.

39 (2) A report of the number and types of COVID-19  
40 vaccines administered to residents of this Commonwealth.

41 (3) A report of the number and types of COVID-19 tests  
42 administered to residents of this Commonwealth.

43 Section 4. Expiration.

44 This act shall expire December 31, 2024.

45 Section 5. Effective date.

46 This act shall take effect immediately.
