20 Section 4. The addition of 67 Pa.C.S. Chs. 71 and 73 is a
21 continuation of the act of November 16, 2005 (P.L.376, No.68),
22 known as the Resource Family and Adoption Process Act, and the
23 act of November 22, 2005 (P.L.404, No.73), known as the Resource
24 Family Care Act. The following apply:

25 (1) Except as otherwise provided in 67 Pa.C.S. Chs. 71
26 and 73, all activities initiated under the Resource Family
27 and Adoption Process Act and the Resource Family Care Act
28 shall continue and remain in full force and effect and may be
29 completed under 67 Pa.C.S. Chs. 71 and 73. Orders,
30 regulations, rules and decisions which were made under the
31 Resource Family and Adoption Process Act and the Resource
32 Family Care Act and which are in effect on the effective date
33 of this section shall remain in full force and effect until
34 revoked, vacated or modified under 67 Pa.C.S. Chs. 71 and 73.
35 Contracts, obligations and collective bargaining agreements
36 entered into under the Resource Family and Adoption Process
37 Act and the Resource Family Care Act are not affected nor
38 impaired by the repeal of the Resource Family and Adoption

1 Process Act and the Resource Family Care Act.
2 (2) Any difference in language between 67 Pa.C.S. Chs.
3 71 and 73 and the Resource Family and Adoption Process Act
4 and the Resource Family Care Act is intended only to conform
5 to the style of the Pennsylvania Consolidated Statutes and is
6 not intended to change or affect the legislative intent,
7 judicial construction or administration and implementation of
8 the Resource Family and Adoption Process Act and the Resource
9 Family Care Act.
