1 Amend Bill, page 1, line 1, by striking out "an amendment"
2 and inserting

3 separate and distinct amendments

4 Amend Bill, page 1, line 2, by inserting after "Governor"
5 and for qualifications of electors

6 Amend Bill, page 1, lines 5 and 6, by striking out all of
7 said lines and inserting

8 Section 1. The following separate and distinct amendments to
9 the Constitution of Pennsylvania are proposed in accordance with
10 Article XI:

11 (1)

12 Amend Bill, page 2, lines 8 through 30, by striking out all
13 of said lines and inserting

14 (2) That section 1 of Article VII be amended to read:

15 § 1. Qualifications of electors.

16 [Every citizen 21] Only citizens 18 years of age or older,
17 possessing the following qualifications, shall be entitled to
18 vote at all elections subject, however, to such laws requiring
19 and regulating the registration of electors as the General
20 Assembly may enact.

21 1. He or she shall have been a citizen of the United States
22 at least one month.

23 2. He or she shall have resided in the State [90] 30 days
24 immediately preceding the election.

25 3. He or she shall have resided in the election district
26 where he or she shall offer to vote at least [60] 30 days
27 immediately preceding the election, except that if qualified to
28 vote in an election district prior to removal of residence, he
29 or she may, if a resident of Pennsylvania, vote in the election
30 district from which he or she removed his or her residence
31 within [60] 30 days preceding the election.

32 4. He or she shall present valid identification prior to
33 voting, regardless of voting method. If an elector does not

1 possess valid identification, he or she shall, upon request, be
2 furnished with a government-issued identification at no cost to
3 the elector. For purposes of this paragraph, the term "valid
4 identification" shall mean any unexpired government-issued
5 identification, unless otherwise authorized by statute.

6 Section 2. (a) Upon the first passage by the General
7 Assembly of these proposed constitutional amendments, the
8 Secretary of the Commonwealth shall proceed immediately to
9 comply with the advertising requirements of section 1 of Article
10 XI of the Constitution of Pennsylvania and shall transmit the
11 required advertisements to two newspapers in every county in
12 which such newspapers are published in sufficient time after
13 passage of these proposed constitutional amendments.

14 (b) Upon the second passage by the General Assembly of these
15 proposed constitutional amendments, the Secretary of the
16 Commonwealth shall proceed immediately to comply with the
17 advertising requirements of section 1 of Article XI of the
18 Constitution of Pennsylvania and shall transmit the required
19 advertisements to two newspapers in every county in which such
20 newspapers are published in sufficient time after passage of
21 these proposed constitutional amendments. The Secretary of the
22 Commonwealth shall:

23 (1) Submit the proposed constitutional amendment under
24 section 1(1) of this resolution to the qualified electors of
25 this Commonwealth as a separate ballot question at the first
26 primary, general or municipal election which meets the
27 requirements of and is in conformance with section 1 of
28 Article XI of the Constitution of Pennsylvania and which
29 occurs at least three months after the proposed
30 constitutional amendment is passed by the General Assembly.

31 (2) Submit the proposed constitutional amendment under
32 section 1(2) of this resolution to the qualified electors of
33 this Commonwealth as a separate ballot question at the first
34 primary, general or municipal election which meets the
35 requirements of and is in conformance with section 1 of
36 Article XI of the Constitution of Pennsylvania and which
37 occurs at least three months after the proposed
38 constitutional amendment is passed by the General Assembly.
