13 Section 101-A. Declaration of policy.

14 The General Assembly finds and declares as follows:

15 (1) There are circumstances under which it is impossible
16 to effectively comply with law relating to State finance or
17 State tax.

18 (2) When circumstances under paragraph (1) arise, it is
19 necessary for Commonwealth agencies to exercise [temporary]
20 powers and duties set forth in this article.

21 Section 1.1. The act is amended by adding sections to read:

22 Section 104-A. Nontaxability of certain income.

23 (a) Forgiveness of Paycheck Protection Loans.--

24 (1) For the purposes of computing the tax under Article
25 III of the act of March 4, 1971 (P.L.6, No.2), known as the
26 Tax Reform Code of 1971, the classes of income under section
27 303 of the Tax Reform Code of 1971 shall not include any
28 amount which is excluded from Federal gross income under
29 sections 276 and 278(a) of the COVID-related Tax Relief Act
30 of 2020, enacted as Subtitle B of Title II of Division N of
31 the Consolidated Appropriations Act, 2021 (Public Law 116-
32 260, 134 Stat. 1182).

33 (2) For the purposes of Article III of the Tax Reform
34 Code of 1971, no deduction may be disallowed for an expense

1 that is otherwise deductible if the payment of the expense
2 results in forgiveness of a covered loan under paragraph (1).
3 (b) Payment received by individuals.--For the purposes of
4 computing the tax under Article III of the Tax Reform Code of
5 1971, the classes of income under section 303 of the Tax Reform
6 Code of 1971 shall not include a payment received by an
7 individual from the United States under section 2201 through the
8 Coronavirus Aid, Relief, and Economic Security Act (Public Law
9 116-136, 134 Stat. 281) or sections 272 and 273 of the COVID-
10 related Tax Relief Act of 2020, enacted as Subtitle B of Title
11 II of Division N of the Consolidated Appropriations Act, 2021
12 (Public Law 116-260, 134 Stat. 1182).

23 (e) Reduction of obligations.--The following shall apply:

24 (1) Any payments received by the landlord or a utility
25 service provider from a payment made under this section shall
26 be used to reduce the amount of the tenant's obligation to
27 the landlord or utility service provider.

28 (2) A landlord or utility service provider shall not be
29 required to waive any outstanding obligations for rent or
30 utility payments as a condition to participate in the
31 program.

32 (3) Except as provided under paragraph (4), amounts
33 provided for rent, rental arrears, utilities and home energy
34 costs and utility and home energy costs arrears shall be made
35 to the lessor or utility on behalf of an applicant.

36 (4) If a landlord or utility service provider refuses to
37 participate in the program, a payment received by an
38 individual must be forwarded to the landlord or utility

1 service provider to reduce the tenant's obligation.
