Repeals are as follows: 33 (1) The General Assembly declares that the repeal under 34 paragraph (2) is necessary to effectuate the addition of 35 section 302(a)(7) and (8).

(2) Section 311 of the act of April 9, 1929 (P.L.177, 1 2 No.175), known as The Administrative Code of 1929, is 3 repealed. 4 Section 3. The addition of section 302(a)(7) and (8) is a continuation of section 311 of the act of April 9, 1929 5 (P.L.177, No.175), known as The Administrative Code of 1929. 6 7 Except as otherwise provided in the addition of section 302(a) 8 (7) or (8) of the act, all activities initiated under section 311 of The Administrative Code of 1929 shall continue and remain 9 in full force and effect and may be completed under section 10 302(a)(7) or (8) of the act.
