1 Amend Bill, page 1, line 4, by striking out the period after
2 "Bridge" and inserting
3 ; designating the interchange of State Route 43, also known as
4 the Mon-Fayette Expressway, with U.S. Route 40, known as Exit
5 22, in Redstone Township, Fayette County, as the PFC Joseph
6 Frank Duda Memorial Interchange KIA WWII U.S.M.C.; and
7 designating the interchange of U.S. Route 40 with State Route
8 4035, also known as Market Street and Spring Street, in
9 Brownsville, Fayette County, as the Corporal Denny Ray Easter
10 Memorial Interchange KIA Vietnam War U.S. Army.

12 Section 2. PFC Joseph Frank Duda Memorial Interchange KIA WWII
13 U.S.M.C.

14 (a) Findings.--The General Assembly finds and declares as
15 follows:

16 (1) PFC Joseph Frank Duda was born March 14, 1921, in
17 Lamberton, Fayette County.

18 (2) On January 26, 1942, PFC Duda enlisted as a Private
19 in the United States Marine Corps Reserve.

20 (3) PFC Duda served during World War II as a member of
21 the First Battalion, Seventh Marines, Third Marine Brigade,
22 Fleet Marine Force aboard the USS Fuller.

23 (4) On April 10, 1942, PFC Duda was appointed Private
24 First Class.

25 (5) On January 9, 1944, PFC Duda was killed in the line
26 of duty as the result of a gunshot wound received in action
27 at Cape Gloucester, New Britain.

28 (b) Designation.--The interchange of State Route 43, also
29 known as the Mon-Fayette Expressway, with U.S. Route 40, known
30 as Exit 22, in Redstone Township, Fayette County, is designated
31 as the PFC Joseph Frank Duda Memorial Interchange KIA WWII
32 U.S.M.C.

33 (c) Signs.--The Pennsylvania Turnpike Commission shall erect
34 and maintain appropriate signs displaying the name of the
35 interchange to traffic in both directions.

36 Section 3. Corporal Denny Ray Easter Memorial Interchange KIA
37 Vietnam War U.S. Army.

1 (a) Findings.--The General Assembly finds and declares as
2 follows:

3 (1) Corporal Denny Ray Easter was born August 28, 1950,
4 in Brownsville, Fayette County.

5 (2) On November 11, 1970, Corporal Easter joined the
6 United States Army and earned the rank of Corporal.

7 (3) Corporal Easter served during the Vietnam War as an
8 Infantryman with B Company, 5th Battalion, 198th Light
9 Infantry Brigade, 46th Infantry, with a specialty of Light
10 Weapons Infantry.

11 (4) On January 13, 1971, at the age of 20, Corporal
12 Easter was killed in the line of duty in Quang Tin province,
13 South Vietnam.

14 (b) Designation.--The interchange of U.S. Route 40 with
15 State Route 4035, also known as Market Street and Spring Street,
16 in Brownsville, Fayette County, is designated as the Corporal
17 Denny Ray Easter Memorial Interchange KIA Vietnam War U.S. Army.

18 (c) Signs.--The Department of Transportation shall erect and
19 maintain appropriate signs displaying the name of the
20 interchange to traffic in both directions.

21 Section 4. Repeals.

22 Repeals are as follows:

23 (1) The General Assembly declares that the repeal under
24 paragraph (2) is necessary to effectuate the designations
25 under sections 2 and 3 of this act.

26 (2) Sections 12 and 13 of the act of July 1, 2020
27 (P.L.536, No.45), entitled "An act designating a portion of
28 Pennsylvania Route 183 from Segment 0040/Offset 2555 to
29 Segment 110/Offset 1180 in Berks County as the Trooper Wayne
30 C. Ebert Memorial Highway; designating a bridge on that
31 portion of S.R. 2087 over Inners Creek near Lake Redman, York
32 Township, York County, as the Corporal Michael Cohen Memorial
33 Bridge; designating a portion of State Route 50 in Mount
34 Pleasant Township, Washington County, as the Corporal Brady
35 Clement Paul Memorial Highway; designating the Morgan Road
36 Bridge over Interstate 79 in Cecil Township, Washington
37 County, as the Wreathes Across America Bridge; designating
38 the Interstate 70 Exit 17 in City of Washington, Washington
39 County, as the Sergeant Russell Crupe, Jr., Memorial Exit;
40 designating a bridge, identified by Bridge Key 7381, on that
41 portion of North Main Street over the East Branch Perkiomen
42 Creek, Sellersville Borough, Bucks County, as the
43 Sellersville Veterans Memorial Bridge; designating a portion
44 of Pennsylvania Route 39 in Dauphin County, from Dover Road
45 to Forest Hills Drive, as the Officer Mark Gaspich Memorial
46 Highway; designating a bridge, identified as Bridge Key
47 11414, on U.S. Route 219 in Brady Township, Clearfield
48 County, as the Lance Corporal Robert Clyde Gontero Memorial
49 Bridge; designating a bridge, identified by Bridge Key 46789,
50 on that portion of State Route 3012 over Back Creek on the
51 border of Hamilton Township and St. Thomas Township, Franklin

1 County, as the Sergeant Melvin G. Ehrhart Memorial Bridge;
2 designating a bridge on that portion of State Route 8042 over
3 U.S. Route 40, West Brownsville Borough, Washington County,
4 as the SFC Thomas McDonough Memorial Bridge; designating the
5 bridge, identified as Bridge Key 53827, on that portion of
6 State Route 2003, also known as S. Porter Street, over the
7 South Fork Tenmile Creek in Waynesburg, Greene County, as the
8 Sheriff Brian A. Tennant Memorial Bridge; designating the
9 interchange of State Route 43, also known as the Mon-Fayette
10 Expressway, with U.S. Route 40, known as Exit 22, in Redstone
11 Township, Fayette County, as the PFC Joseph Frank Duda
12 Memorial Interchange; and designating the interchange of U.S.
13 Route 40 with State Route 4035, also known as Market Street
14 and Spring Street, in Brownsville, Fayette County, as the
15 Corporal Denny Ray Easter Memorial Interchange."
