6 Section 2003-B. Qualification and application by organizations.

8 (c) Scholarship organizations and pre-kindergarten  
9 scholarship organizations.--A scholarship organization or pre-  
10 kindergarten scholarship organization must certify to the  
11 department that the organization is eligible to participate in  
12 the educational improvement tax credit program established under  
13 this article and must agree to annually report the following  
14 information to the department by November 1 of each year:

15 (1) (i) The number of scholarships awarded during the  
16 immediately preceding school year to eligible pre-  
17 kindergarten students.

18 (ii) The total and average amounts of the  
19 scholarships awarded during the immediately preceding  
20 school year to eligible pre-kindergarten students.

21 (iii) The number of scholarships awarded during the  
22 immediately preceding school year to eligible students in  
23 grades kindergarten through eight.

24 (iv) The total and average amounts of the  
25 scholarships awarded during the immediately preceding  
26 school year to eligible students in grades kindergarten  
27 through eight.

28 (v) The number of scholarships awarded during the  
29 immediately preceding school year to eligible students in  
30 grades nine through 12.

31 (vi) The total and average amounts of the  
32 scholarships awarded during the immediately preceding  
33 school year to eligible students in grades nine through  
34 12.

35 (vii) Where the scholarship organization or pre-  
36 kindergarten scholarship organization collects  
37 information on a county-by-county basis, the total number

1 and the total amount of scholarships awarded during the  
2 immediately preceding school year to residents of each  
3 county in which the scholarship organization or pre-  
4 kindergarten scholarship organization awarded  
5 scholarships.

6 (viii) The total number of scholarship applications  
7 processed and the amounts of any application fees  
8 charged, either per scholarship application or in the  
9 aggregate through a third-party processor.

10 (ix) The organization's Federal Form 990 or other  
11 Federal form indicating the tax status of the  
12 organization for Federal tax purposes, if any, and a copy  
13 of a compilation, review or audit of the organization's  
14 financial statements conducted by a certified public  
15 accounting firm.

16 (x) Any other information requested by the  
17 department.

19 [(3) The department may not require any other  
20 information to be provided by scholarship organizations or  
21 pre-kindergarten scholarship organizations, except as  
22 expressly authorized in this article.]
