Additional property tax reduction allocation. (a) Allocation .-- Notwithstanding any other provision of law, 20 a school district shall receive an allocation equal to the total 21 22 number of farmstead properties plus the total number of 23 homestead properties in the school district multiplied by 24 \$1,000. 25 (b) Uses.--A school district shall use the allocation under subsection (a) to provide an additional exclusion equal to 50% 26 of the real estate tax due to the school district for each 27 farmstead property and homestead property in the school 28 29 district, or \$1,000, whichever is less. 30 (c) Report and certification. -- Prior to the allocation of funds under subsection (a), a school district shall submit a 31 report to the Department of Education with the total number of 32 33 farmstead properties and homestead properties in the school district and the total amount of real estate taxes to be 34 reduced. The Department of Education shall certify the total 35 number of all farmstead properties and all homestead properties 36 reported and the total amount of real estate taxes to be 37
