16 (1) The department shall provide administrative services  
17 and staff, including counsel and legal staff, to the office  
18 and to the advisory committee.

19 (2) The office shall reimburse the department for the  
20 cost and expenses of providing the administrative services  
21 and staff under paragraph (1). No more than 5% of the funding  
22 appropriated annually to the office shall be used for  
23 administrative costs and expenses.

28 Section 303. Office of New Pennsylvanians Restricted Account.

1 The Office of New Pennsylvanians Restricted Account is  
2 established as a restricted account in the General Fund. Money  
3 appropriated by the General Assembly for the office shall be  
4 deposited in the restricted account for use by the office to  
5 carry out its powers and duties under section 302.

15 Section 701. Applicability of other statutes.

16 The following acts shall apply to the office and the advisory  
17 committee:

18 (1) The act of July 19, 1957 (P.L.1017, No.451), known  
19 as the State Adverse Interest Act.

20 (2) The act of February 14, 2008 (P.L.6, No.3), known as  
21 the Right-to-Know Law.

22 (3) The provisions of 65 Pa.C.S. Chs. 7 (relating to  
23 open meetings) and 11 (relating to ethics standards and  
24 financial disclosure).
