15 § 9. Action on concurrent orders and resolutions.

16 Every order, resolution or vote, to which the concurrence of

17 both Houses may be necessary, except on the questions of

18 adjournment, disapproval of a regulation or termination or

19 extension of a disaster emergency declaration as declared by an

20 executive order or proclamation, or portion of a disaster

21 emergency declaration as declared by an executive order or

22 proclamation, shall be presented to the Governor and before it

23 shall take effect be approved by him, or being disapproved,

24 shall be repassed by two-thirds of both Houses according to the

25 rules and limitations prescribed in case of a bill.

26 (2) That section 1 of Article VII be amended to read:

1 Section 2. The following procedure applies to the proposed  
2 constitutional amendments in this joint resolution:

3 (1) Upon first passage by the General Assembly of the  
4 amendments, the Secretary of the Commonwealth shall proceed  
5 immediately to comply with the advertising requirements of  
6 section 1 of Article XI of the Constitution of Pennsylvania.

7 (2) Upon the second passage of the amendments by the  
8 General Assembly, the Secretary of the Commonwealth shall  
9 proceed immediately to comply with the advertising  
10 requirements of section 1 of Article XI of the Constitution  
11 of Pennsylvania. The Secretary of the Commonwealth shall:

12 (i) Submit the amendment under section 1(1) of this  
13 resolution to the qualified electors of this Commonwealth  
14 as a separate ballot question at the first primary  
15 election which meets the requirements of section 1 of  
16 Article XI of the Constitution of Pennsylvania.

17 (ii) Submit the amendment under section 1(2) of this  
18 resolution to the qualified electors of this Commonwealth  
19 as a separate ballot question at the first primary  
20 election which meets the requirements of section 1 of  
21 Article XI of the Constitution of Pennsylvania.
