16 distillery license or held an active limited distillery license
17 prior to July 1, 2024, and subsequently acquired a distillery
18 license.

20 DRINK COCKTAILS"

21 Amend Bill, page 55, line 28, by striking out "AN ENTITY
22 LICENSED UNDER SECTION 505.4." and inserting

24 Pennsylvania manufacturer" under section 415.1(i).

25 (ii) For any licensee to acquire an alcoholic beverage that
26 meets the definition of a "ready-to-drink cocktail" from anyone

1 other than the board, or an entity that meets the definition of
2 a "licensed Pennsylvania manufacturer" under section 415.1(i),
3 except that a licensee may acquire an alcoholic beverage that
4 meets the definition of a "ready-to-drink cocktail" from an
5 entity licensed under section 505.4, if the purchasing licensee
6 does not resell the alcoholic beverage for off-premises
7 consumption.

16 Pennsylvania manufacturer" under section 415.1(i) must, upon
17 request, offer to sell to the board any ready-to-drink cocktail
18 the licensed Pennsylvania manufacturer sells.

19 (e) An entity that meets the definition of a "licensed
20 Pennsylvania manufacturer" under section 415.1(i) that sells
21 ready-to-drink cocktails to licensees that hold a ready-to-drink
22 cocktail permit shall report quarterly in writing to the board
23 the following:

24 (i) The quantity of product sold to each permittee.

25 (ii) The purchase price to permittees.

26 (iii) The name or brand of the product sold.
