## AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in collective bargaining, providing 5 for notice prior to approval of collective bargaining 6 agreement. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. The act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, is amended by adding a 11 12 section to read: 13 Section 1153-A. Notice Prior to Approval of Collective Bargaining Agreement. -- (a) A board of school directors of any 14 15 school district shall provide notice prior to voting upon any proposed collective bargaining agreement. The notice required
- 18 (1) Be posted on the school district's publicly accessible

under this section shall:

- 19 Internet website beginning at least two (2) weeks prior to the
- public meeting of the board of school directors at which the 20

- 1 board of school directors votes upon the proposed collective
- 2 bargaining agreement and continuing at least until thirty (30)
- 3 days following the conclusion of such public meeting.
- 4 (2) Be published at least one (1) time in a newspaper of
- 5 general circulation in the school district at least two (2)
- 6 weeks prior to the public meeting of the board of school
- 7 directors at which the board of school directors votes upon the
- 8 proposed collective bargaining agreement.
- 9 <u>(3) Include the following:</u>
- 10 (i) a statement of the terms of the proposed collective
- 11 <u>bargaining agreement; and</u>
- 12 (ii) an estimate of the costs to the school district
- 13 <u>associated with the proposed collective bargaining agreement.</u>
- 14 (b) The notice requirements of this section shall not apply
- 15 <u>to section 1125-A(k).</u>
- 16 <u>(c) The Department of Education shall promulgate regulations</u>
- 17 pursuant to the act of June 25, 1982 (P.L.633, No.181), known as
- 18 the "Regulatory Review Act," to set forth the form of the notice
- 19 required under subsection (a).
- 20 Section 2. This act shall take effect in 60 days.
