AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, further providing for inspection of garages and
- dealer premises by police; and requiring certain persons to
- 4 keep accurate records of motor vehicle sales and
- 5 dispositions.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 6308 of Title 75 of the Pennsylvania
- 9 Consolidated Statutes is amended to read:
- 10 § 6308. Investigation by police officers.
- 11 (a) Duty of operator or pedestrian. -- The operator of any
- 12 vehicle or any pedestrian reasonably believed to have violated
- 13 any provision of this title shall stop upon request or signal of
- 14 any police officer and shall, upon request, exhibit a

- 1 registration card, driver's license and information relating to
- 2 financial responsibility, or other means of identification if a
- 3 pedestrian or driver of a pedalcycle, and shall write their name
- 4 in the presence of the police officer if so required for the
- 5 purpose of establishing identity.
- 6 (b) Authority of police officer.--Whenever a police officer
- 7 is engaged in a systematic program of checking vehicles or
- 8 drivers or has articulable and reasonable grounds to suspect a
- 9 violation of this title, he may stop a vehicle, upon request or
- 10 signal, for the purpose of checking the vehicle's registration,
- 11 proof of financial responsibility, vehicle identification number
- 12 or engine number or the driver's license, or to secure such
- 13 other information as the officer may reasonably believe to be
- 14 necessary to enforce the provisions of this title.
- 15 (c) Inspection of garages and dealer premises. -- Any police
- 16 officer or authorized department employee may inspect any
- 17 vehicle in any [public] garage or repair shop or on the premises
- 18 of any dealer, salvor, scrap metal processor, or other public
- 19 place of business for the purpose of locating stolen vehicles or
- 20 parts or vehicles or vehicle parts with identification numbers
- 21 removed or falsified. The owner of the garage or repair shop or
- 22 the dealer or other person shall permit any police officer or
- 23 authorized department employee to make investigations under this
- 24 subsection.
- 25 <u>(d) Records.--Every salvor, junkyard operator, scrap metal</u>
- 26 processor, designated agent and dealer shall keep accurate
- 27 records of motor vehicle sales and dispositions. The records
- 28 shall include the make, year and type of vehicle, from whom
- 29 <u>purchased or acquired, and date, vehicle identification number</u>
- 30 and date of sale or disposition of vehicle. The records shall be

- 1 available on the premises of the salvor, junkyard operator,
- 2 scrap metal processor, designated agent and new or used car
- 3 <u>dealer</u> and open to inspection by any police officer or
- 4 <u>authorized department employee</u>. The records shall be maintained
- 5 for three years from the date of disposition of the vehicle.
- 6 (e) Penalty. -- Any person violating subsection (d) commits a
- 7 misdemeanor of the third degree.
- 8 Section 2. This act shall take effect in 60 days.
