AN ACT

1 Amending Title 24 (Education) of the Pennsylvania Consolidated  
2 Statutes, further defining "superannuation or normal  
3 retirement age."

4 The General Assembly of the Commonwealth of Pennsylvania  
5 hereby enacts as follows:

6 Section 1. The definition of "superannuation or normal  
7 retirement age" in section 8102 of Title 24 of the Pennsylvania  
8 Consolidated Statutes is amended to read:

9 § 8102. Definitions.

10 The following words and phrases when used in this part shall  
11 have, unless the context clearly indicates otherwise, the  
12 meanings given to them in this section:

13       Section 2. This act shall take effect July 1, 1987, or  
14 immediately, whichever is later.
