## A RESOLUTION

1 Declaring that May 12 through 18, 2002, be observed as "National  
2 Nursing Home Week" in Pennsylvania.

6 homes provide critical services in the continuum of long-term  
7 care for many citizens of this Commonwealth; and

8 WHEREAS, It is appropriate that Commonwealth nursing homes  
9 join the nation to observe "National Nursing Home Week";

1       RESOLVED, That the House of Representatives declare that May  
2   12 through 18, 2002, be observed as "National Nursing Home Week"  
3   in Pennsylvania and urge all citizens to join in recognizing the  
4   significant contributions of nursing facilities and caregivers  
5   in this Commonwealth and beyond.
