AN ACT

- 1 Authorizing the Department of General Services, with the
- approval of the Governor and the Department of Corrections,
- to grant and convey to Schuylkill County certain lands
- situate in Ryan Township, Schuylkill County.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Conveyance in Ryan Township, Schuylkill County.
- 8 (a) Authorization. -- The Department of General Services, with
- 9 the approval of the Governor and the Department of Corrections,
- 10 is hereby authorized on behalf of the Commonwealth of
- 11 Pennsylvania to grant and convey to Schuylkill County
- 12 approximately 4.748-acres of vacant land together with a 50 foot
- 13 wide ingress and egress easement as described in subsection (b)
- 14 for \$48,000.00 and under terms and conditions to be established
- 15 in an Agreement of Sale with the Department of General Services.
- 16 (b) Description. -- The property to be conveyed, pursuant to
- 17 this section consists of approximately 4.748 acres of land
- 18 thereon more particularly described as follows:

- 1 BEGINNING at a point, an iron pin at the intersection of the
- 2 south right-of-way line of Prison Road, a proposed 50' wide
- 3 right-of-way, and the east right-of-way line of PP&L Company;
- 4 said point being located, S 51-37-36E 72.13' and S 51-37-36
- 5 E-108.47' from a disk at the intersection of the south right-of-
- 6 way line of Interstate 81 and the east right-of-way line of PP&L
- 7 Company; thence from the place of beginning along the above-

- 28 PP&L Company; thence continuing through the same and along PP&L
- 29 Company east right-of-way line, N 51-37-36 W 1102.35' to the
- 30 place of beginning.

- 24 records in UPI No. 26-06-0014, 26-06-0015 and 26-06-0007.
- 25 CONTAINING 2.176-acres or 94,766 square feet.
- 26 (c) Easements.--The conveyance shall be made under and
- 27 subject to all lawful and enforceable easements, servitudes and
- 28 rights of others, including but not confined to streets,
- 29 roadways and rights of any telephone, telegraph, water,
- 30 electric, gas or pipeline companies, as well as under and

- 1 subject to any lawful and enforceable estates or tenancies
- 2 vested in third persons appearing of record, for any portion of
- 3 the land or improvements erected thereon.
- 4 (d) Restriction. -- The conveyance authorized under this
- 5 section shall be made under and subject to the condition, which
- 6 shall be contained in the deed of conveyance, that no portion of
- 7 the property conveyed shall be used as a licensed facility, as
- 8 defined in 4 Pa.C.S. § 1103 (relating to definitions), or any
- 9 other similar type of facility authorized under State law. The
- 10 condition shall be a covenant running with the land and shall be
- 11 binding upon the Grantee, its successors and assigns. Should the
- 12 Grantee, its successors or assigns, permit any portion of the
- 13 property authorized to be conveyed in this section to be used in
- 14 violation of this subsection, the title shall immediately revert
- 15 to and revest in the Grantor.
- 16 (e) Deed of conveyance. -- The deed of conveyance shall be
- 17 executed by the Secretary of General Services in the name of the
- 18 Commonwealth of Pennsylvania.
- 19 (f) Costs and fees. -- Costs and fees incidental to this
- 20 conveyance shall be borne by the Grantee.
- 21 (q) Expiration of authorization. -- In the event that an
- 22 agreement of sale between the parties is not executed within two
- 23 years of the effective date of this section, the authorization
- 24 contained in this section shall expire.
- 25 Section 2. Effective date.
- 26 This act shall take effect immediately.
