AN ACT

- Amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, providing for older student
- protection; and imposing a penalty.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 23 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a chapter to read:

- 11 6401. Definitions.
- 12 <u>6402</u>. Reporting process.
- 13 <u>6403</u>. Contents of report.
- 14 6404. Penalty for failure to report.
- 15 <u>6405</u>. <u>Investigation</u>.
- 16 § 6401. Definitions.
- 17 The following words and phrases when used in this chapter

- 1 shall have the meanings given to them in this section unless the
- 2 context clearly indicates otherwise:
- 3 "Administrator." The person responsible for the
- 4 <u>administration of a public or private school, intermediate unit</u>
- 5 or area vocational-technical school.
- 6 <u>"Department." The Department of Public Welfare of the</u>
- 7 Commonwealth.
- 8 "Law enforcement official." The term shall include:
- 9 <u>(1) A police officer of a municipality.</u>
- 10 (2) A district attorney.
- 11 (3) The Pennsylvania State Police.
- 12 <u>(4) A county sheriff.</u>
- 13 <u>(5) The Attorney General.</u>
- 14 "School employee." An individual employed by a public or
- 15 private school, intermediate unit or area vocational-technical
- 16 <u>school</u>. The term includes an independent contractor and
- 17 employees. The term does not include an individual who has no
- 18 direct contact with students.
- 19 "Serious bodily injury." An injury that:
- 20 (1) creates a substantial risk of death; or
- 21 (2) causes serious permanent disfigurement or protracted
- loss or impairment of the function of a body member or organ.
- 23 "Serious injury." An injury that:
- (1) causes a person severe pain; or
- 25 (2) significantly impairs a person's physical or mental
- functioning, either temporarily or permanently.
- 27 <u>"Sexual abuse." Intentionally, knowingly or recklessly</u>
- 28 causing or attempting to cause rape, involuntary deviate sexual
- 29 <u>intercourse</u>, <u>sexual assault</u>, <u>statutory sexual assault</u>,
- 30 aggravated indecent assault or incest, as defined by 18 Pa.C.S.

- 1 (relating to crimes and offenses).
- 2 "Student." An individual enrolled in a public or private
- 3 school, intermediate unit or area vocational-technical school
- 4 who meets all of the following:
- 5 <u>(1) Is 18 years of age or older.</u>
- 6 (2) Suffers from serious mental or learning
- 7 disabilities.
- 8 (3) Has been placed in an individualized education
- 9 <u>program.</u>
- 10 § 6402. Reporting process.
- 11 (a) Requirements.--
- 12 (1) Except as provided under paragraph (3), a school
- 13 <u>employee who has reasonable cause to suspect, on the basis of</u>
- 14 <u>professional or other training and experience, that a student</u>
- is a victim of sexual abuse, serious injury or serious bodily
- 16 <u>injury shall immediately notify the administrator of the</u>
- 17 school.
- 18 (2) The administrator of a school shall immediately
- 19 report suspected sexual abuse, serious injury or serious
- 20 bodily injury to law enforcement officials as follows:
- 21 (i) Upon receiving notification by a school employee
- 22 of suspected sexual abuse, serious injury or serious
- bodily injury under paragraph (1).
- 24 (ii) If the administrator has cause to suspect
- 25 sexual abuse, serious injury or serious bodily injury of
- a student.
- 27 (3) If the individual suspected of abusing or injuring
- the student is the administrator of the school, the school
- 29 <u>employee shall immediately report the suspected sexual abuse</u>,
- 30 serious injury or serious bodily injury to law enforcement

- 1 officials.
- 2 (4) A school employee may not reveal the existence or
- 3 content of a report under this subsection to any other
- 4 person.
- 5 (b) Immunity.--A school employee or administrator who makes
- 6 <u>a report under subsection (a) shall be immune from civil and</u>
- 7 <u>criminal liability arising out of the report.</u>
- 8 § 6403. Contents of report.
- 9 The report shall include, at a minimum, the following
- 10 information:
- 11 (1) Name, age and address of the student.
- 12 (2) Name and address of the student's guardian,
- 13 <u>attorney-in-fact or next of kin.</u>
- 14 (3) Name and address of the school.
- 15 (4) Nature of the alleged offense.
- 16 (5) Specific comments or observations that are directly
- 17 related to the alleged incident and those involved.
- 18 § 6404. Penalty for failure to report.
- 19 A school employee or administrator who willfully violates
- 20 section 6402 (relating to reporting process) commits a
- 21 misdemeanor of the third degree.
- 22 § 6405. Investigation.
- 23 (a) General rule.--Upon receipt of the report under section
- 24 6402 (relating to reporting process), an investigation shall be
- 25 conducted by law enforcement officials in cooperation with the
- 26 district attorney, and a determination must be made as to what
- 27 <u>criminal charges, if any, will be filed in connection with the</u>
- 28 report.
- 29 (b) Notification.--If law enforcement officials have
- 30 reasonable cause to suspect on the basis of initial review that

- 1 there is evidence of serious bodily injury, sexual abuse or
- 2 <u>serious injury committed by an individual against a student,</u>
- 3 local law enforcement officials shall notify a local contracted
- 4 provider of adult protective services under the act of October
- 5 7, 2010 (P.L.484, No.70), known as the Adult Protective Services
- 6 Act, and the department to determine if protective services are
- 7 needed for the student.
- 8 Section 2. The addition of 23 Pa.C.S. Ch. 64 shall apply to
- 9 reports made on or after the effective date of this section.
- 10 Section 3. This act shall take effect in 60 days.
