- 5 WHEREAS, House Resolution No. 155, Printer's No. 3060 (1982),
- 6 adopted by the House of Representatives on March 23, 1982,
- 7 specifies certain powers and duties of the Legislative Committee
- 8 for Research Liaison (LORL Committee); and
- 9 WHEREAS, The LORL Committee is authorized to receive
- 10 applications and prepare for ratification by the House of
- 11 Representatives, prior to the beginning of an odd-numbered
- 12 calendar year, the list of new participating organizations, if
- 13 any, deemed appropriate for carrying out the purposes of House
- 14 Resolution No. 155 of 1982; and
- 15 WHEREAS, The LORL Committee has adopted terms and conditions
- 16 to be met by any participating organization; and
- 17 WHEREAS, The Association of Independent Colleges and
- 18 Universities of Pennsylvania, representing the 83 private

- 1 academic institutions in this Commonwealth, seeks membership as
- 2 a LORL participating organization; and
- 3 WHEREAS, The Association of Independent Colleges and
- 4 Universities of Pennsylvania has submitted in writing to the
- 5 LORL Committee cochairs an application for membership and
- 6 evidence of ability to meet the terms and conditions for
- 7 participating organizations as required by the LORL Committee;
- 8 and
- 9 WHEREAS, The LORL Committee, having reviewed the application
- 10 and having met with appropriate personnel from the applicant
- 11 organization, unanimously recommends the Association of
- 12 Independent Colleges and Universities of Pennsylvania to the
- 13 House of Representatives for ratification as a participating
- 14 organization; therefore be it
- 15 RESOLVED, That the House of Representatives of Pennsylvania
- 16 approve the Association of Independent Colleges and Universities
- 17 of Pennsylvania as a LORL participating organization, effective
- 18 January 1, 2005, for the purposes of House Resolution No. 155 of
- 19 1982.
