AN ACT

1 Amending Title 71 (State Government) of the Pennsylvania
2 Consolidated Statutes, adding certain employees to the State
3 Employees' Retirement System.

4 The General Assembly of the Commonwealth of Pennsylvania
5 hereby enacts as follows:

6 Section 1. The definition of "State employee" in section
7 5102 of Title 71, act of November 25, 1970 (P.L.707, No.230),
8 known as the Pennsylvania Consolidated Statutes, added March 1,
9 1974 (No.31), is amended by adding a paragraph to read:

10 § 5102. Definitions.

11 The following words and phrases as used in this part, unless
12 a different meaning is plainly required by the context, shall
13 have the following meanings:

14 * * *

15 "State employee." Any person holding a State office or
16 position under the Commonwealth, employed by the State
17 Government of the Commonwealth, in any capacity whatsoever,
18 except an independent contractor or any person compensated on a

1 fee basis, and shall include members of the General Assembly,
2 and officer or employee of the following:

3 * * *

4 (5) An employee of a soil conservation district who is
5 compensated for his services with funds contributed by the
6 Commonwealth or a political subdivision thereof.

7 * * *

8 Section 2. Section 5505 of Title 71 of the act, added March
9 1, 1974 (No.31), is amended by adding a subsection to read:

10 § 5505. Contributions for the purchase of credit for creditable
11 nonstate service.

12 * * *

13 (f) Contributions on account of credit for service as an
14 employee of a soil conservation district shall be determined by
15 the board to be equal to the amount he would have paid as
16 employee contributions together with statutory interest to date
17 of purchase had he been a State employee during his period of
18 service as an employee of a soil conversation district. The
19 amount so determined by the State Employees' Retirement Board to
20 be paid into the State Employees' Retirement System shall be the
21 obligation of the employee who requested credit for previous
22 service as an employee of a soil conservation district.

23 Section 3. Section 5507 of Title 71 of the act, added March
24 1, 1974 (No.31), is amended by adding a subsection to read:

25 § 5507. Contributions by the Commonwealth and other employers.

26 * * *

27 (c) Contributions shall be made by soil conservation
28 districts on behalf of employees thereof who are not paid out of
29 Commonwealth funds.
