AN ACT

- 1 Appropriating moneys in the Land and Water Development Fund
- 2 derived from the issuance and sale of bonds and notes
- 3 pursuant to the act of January 19, 1968 (P.L.996), known as
- 4 "The Land and Water Conservation and Reclamation Act."
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The following sums are hereby appropriated for
- 8 the periods and purposes specified from moneys in the Land and
- 9 Water Development Fund derived from the issuance and sale of
- 10 bonds and notes pursuant to the act of January 19, 1968
- 11 (P.L.996), known as "The Land and Water Conservation and
- 12 Reclamation Act":
- 13 (1) The sum of forty million dollars (\$40,000,000), or as
- 14 much thereof as may be necessary, is hereby appropriated for two
- 15 fiscal years beginning July 1, 1971, to the Department of
- 16 Environmental Resources for the purposes specified in clause (1)
- 17 of subsection (a) of section 16 of the act.

- 1 (2) The sum of twenty million dollars (\$20,000,000), or as
- 2 much thereof as may be necessary, is hereby appropriated for two
- 3 fiscal years beginning July 1, 1971 to the Department of
- 4 Environmental Resources for the purposes specified in clause (2)
- 5 of subsection (a) of section 16 of the act including related
- 6 planning.
- 7 (3) The sum of twenty-five million dollars (\$25,000,000), or
- 8 as much thereof as may be necessary, is hereby appropriated for
- 9 two fiscal years beginning July 1, 1971, to the Department of
- 10 Environmental Resources, Fish and Game Commissions and
- 11 Historical and Museum Commission for the purposes specified in
- 12 clause (3) of subsection (a) of section 16 of the act.
- 13 (4) The sum of fifteen million dollars (\$15,000,000), or as
- 14 much thereof as may be necessary, is hereby appropriated for two
- 15 fiscal years beginning July 1, 1971, to the Department of
- 16 Community Affairs for the purposes specified in clause (4) of
- 17 subsection (a) of section 16 of the act.
- 18 Section 2. This act shall take effect July 1, 1971.
