## AN ACT

- 1 Making appropriations to the Trustees of the University of 2 Pennsylvania.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. The following sums, or as much thereof as may be
- 6 necessary, are hereby appropriated to the Trustees of the
- 7 University of Pennsylvania for the fiscal year July 1, 1985, to
- 8 June 30, 1986, for the purposes and in the amounts as shown:
- 9 (1) For instruction excluding Veterinary
- 10 Medicine programs and Doctor of Medicine but
- 11 including participation by a representative of the
- 12 institution, appointed by the chief executive
- 13 officer thereof, as a member of the Pennsylvania
- 14 Academic Commission on Technological Development,
- 15 a commission for interinstitutional communication
- 16 regarding technological innovation and development

1	and for dissemination of information on such	
2	matters to the Pennsylvania business community and	
3	others who may use such information for new	
4	business and job development in Pennsylvania, such	
5	commission to be composed of representatives of	
6	every State-owned or State-related educational or	
7	scientific institution receiving General Fund

20	Section 2. Payments to the University of Pennsylvania on	
21	account of the appropriations for the items provided in section	
22	1 shall be made quarterly by the Secretary of Education on the	
23	basis of costs during the fiscal year.	
24	Section 3. The University of Pennsylvania shall provide such	
25	information and in such form and manner as the Department of	
26	Education may prescribe.	
27	Section 4. The University of Pennsylvania shall report its	
28	revenues and expenditures and present its financial statements	
29	in accordance with generally accepted accounting principles and	
30	procedures for educational institutions as set forth in the	

- "Higher Education Finance Manual of 1975," without exception. 1
- Section 5. This act shall take effect July 1, 1985, or 2
- 3 immediately, whichever is later.
