AN ACT

- Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An act to consolidate, editorially revise, and codify the public welfare laws of the Commonwealth," authorizing a program for the provision of assistance and counseling to women with crisis pregnancies who have chosen to carry their pregnancies
- 6 to full term; and making an appropriation.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. The act of June 13, 1967 (P.L.31, No.21), known
- 10 as the Public Welfare Code, is amended by adding a section to
- 11 read:
- 12 Section 212. Program of Assistance and Counseling for Women
- 13 with Crisis Pregnancies. -- The department shall establish and
- 14 implement a program for the purchase of services from nonprofit
- 15 agencies exempt from Federal taxation under section 501(c)(3) of
- 16 the Internal Revenue Code of 1954 (68A Stat. 3, 26 U.S.C. §
- 17 501(c)(3)) which exclusively provides assistance and counseling

- 1 to women faced with crisis pregnancies who have chosen to carry
- 2 their pregnancies to full term. No funds from this program shall
- 3 be used for the purchase of services from any agency that
- 4 conditions its services upon an agreement to place the child for
- 5 adoption. In order to be eligible for a purchase of services
- 6 contract authorized under this section, an agency shall
- 7 <u>establish to the satisfaction of the department that it has been</u>
- 8 <u>a nonprofit agency as described in this section for at least</u>
- 9 twelve consecutive months prior to its application for any
- 10 <u>funding provided to implement this section and that it has, for</u>
- 11 that same twelve-month period, been exclusively providing
- 12 <u>counseling and assistance services to pregnant women who choose</u>
- 13 to carry their pregnancies to full term.
- 14 Section 2. The sum of \$2,000,000 is hereby appropriated, as
- 15 a continuing, nonlapsing appropriation, to the Department of
- 16 Public Welfare for the purpose of purchasing the services
- 17 authorized by section 1 of this act.
- 18 Section 3. This act shall take effect immediately.
